This is to certify that the above residential sewage system has a renewed inspections agreement per the Texas Commission on Environmental Quality (TCEQ) standards for on-site sewage facilities (OSSF) as required. All repairs, maintenance, and water testing shall be done in accordance with the manufacturer and the TCEQ rules and regulations. Allen Franques is certified by the manufacturer of the above referenced system.

Alcam Advantage Waste Water Service (AAWWS), 6709 Singleton Bend Road, Marble Falls TX, will inspect and perform routine service of all parts of the OSSF at each scheduled inspection, and will file inspection reports with the authorized agency as required by the TCEQ regulations. Three (3) such inspections shall be done per year. Included in the routine service at each scheduled inspection for spray systems is the replenishment of up to seven (7) chlorine tablets. Maintaining chlorine between inspections is the Homeowner's responsibility. Denying AAWWS access to the OSSF for routine service for six (6) months will be grounds for terminating this contract without refund.

Systems equipped with a working auto-dialer will be monitored by a direct dial system, 512-660-3994. However, should service be required between scheduled inspections, it is the Homeowner's responsibility to inform AAWWS as soon as possible. Upon being notified, AAWWS will respond within two (2) business days.

This agreement does not include the cost of repairs or pumping out the system, and is not an extension of warranty on material or labor used to construct or repair this OSSF. Service calls are \$65 per hour, plus material, due at the time of service. However, the service call fee will be waived for the first such visit per year for residential customers. Payments not received within 30 days of service constitute a breach of this contract, and will be reason for discontinued service.

In the event the above referenced property is sold, this contract transfers to the new Homeowner. There are no refunds for time remaining on this agreement at the time of sale. The Homeowner is responsible for notifying AAWWS of any changes in ownership.
